This generally excludes RRSP assets and property held solely for personal use. This form must be filed separately from the Tax Return.
S3	NB: Please notify us of any Sale of a Principal Residence in this tax year. Information re year of acquisition and sale price must be reported to CRA.

For 2024, CRA has eliminated the special COVID "Home Office Expense" claims which were in effect for 2020, 2021, and 2022. As a result the 2024 tax year has now reverted back to the prior PRE-COVID rules which were in place up to 2019.

NB: No home office claims are allowed if the employee has been reimbursed by the employer for these costs.
